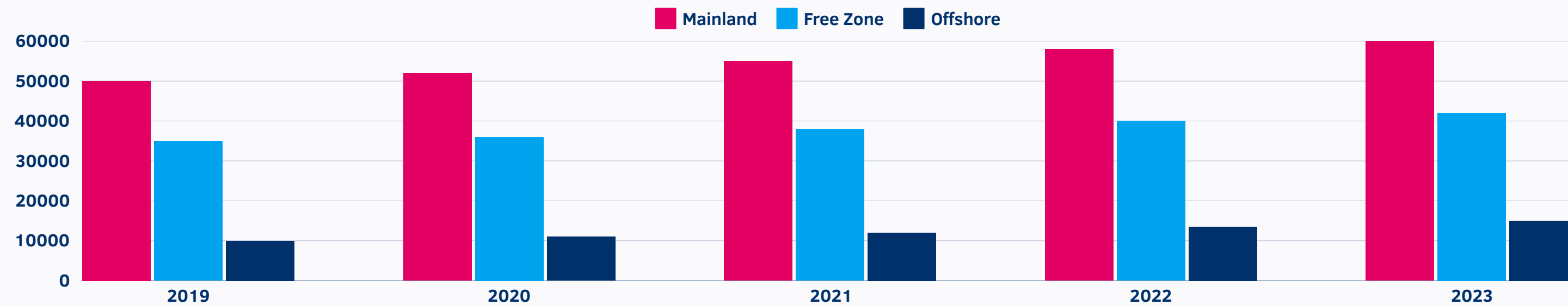

Over the past five years, the UAE has experienced significant growth in business setups, reflecting its attractive economic environment and supportive policies.

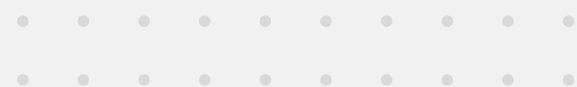


+20% Growth in Mainland

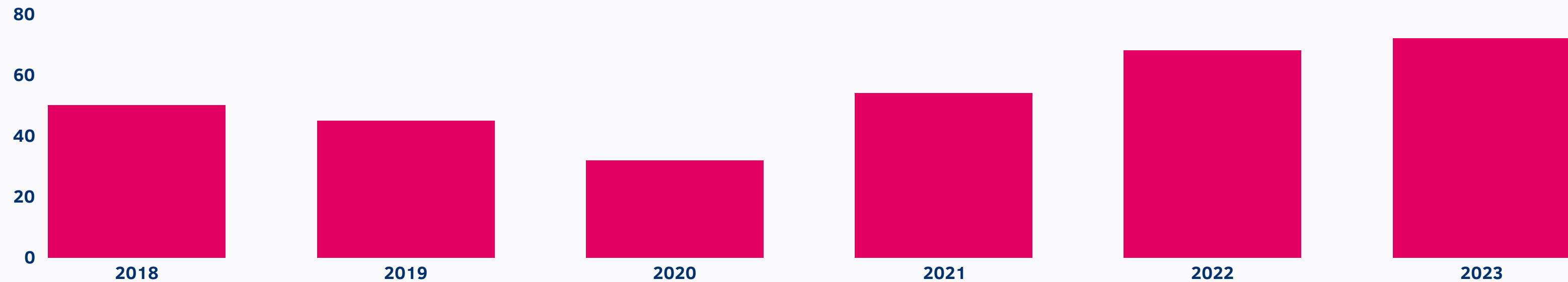
